Eligibility for Branch Change :


1. The student must be enrolled for BE degree through CET only.
2. Student must have passed with CGPA more than or equal to 6.5
3. He /She must have earned all the credits of first year in first two semesters only.
4. Change of branch will be done as per rule no.10 of institute rules and regulations.
5. Over & above candidates like TFWS/J&K Migrants/GOI Nominee/DSE Admitted candidates are NOT ELIGIBLE.
6. Once the branch change is given, no further changes will be entertained.
7. It will be the responsibility of Candidate to complete all requirements for the grant of term after branch change.

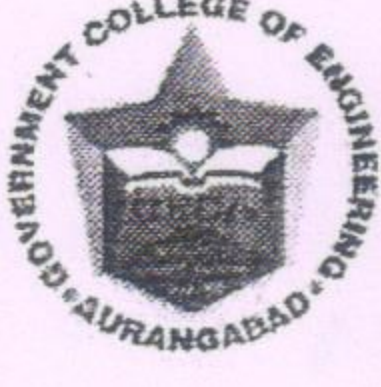
