STEP 1	Repairing & Removing of existing damage plank and providing & fixing new plank against damaged floor planks. (21 mm thick, 63 mm + width and in random length in tongue and groove shape. STEP 2	After installation the damaged planks the floor will be machine sanded in uniform level first to remove the exiting polish. After it gaps filling between the plank and the floor will be again sanded to level the gaps and floor including all material and labour.			
STEP 3	Finished with double coat of PU Polishing water based polyurethane lacquer with matte finish including all labour and materials complete.			
STEP 4	Game line marking to be carried out in required colour before applying the finish coat.
