
- 3.1 The contract shall be for the full quantity as described above.

1	Accelerated curing tank	<ol style="list-style-type: none">1. Accelerated Curing Tank shall be of stainless steel and shall accommodate 12 Concrete Cubes of 150mm size.2. It shall have easily maintainable high wattage heater installed in the heating chamber.3. It shall have a slow speed stirrer to circulate water inside the chamber to maintain the uniform temperature of water. A strong stainless steel perforated platform shall be there for keeping the cubes and also have a lid with lifting handle to cover the chamber.4. It shall have facility for accelerated curing by Boiling water method up to temperature range : 100 +/- 20C as per IS standard IS : 9013 for appropriate time. The temperature shall not drop by more than 30C and shall return to boiling within 15 minutes.5. It shall also have capacity for curing by warm water method at temperature 55 +/- 20C for appropriate time as per IS 90136. The temperature shall be indicated and controlled by a DIGITAL auto tuning PID Temperature Controller with soak timer to control the duration of heating and then to shut down the system without manual attendance.
