The Chairman Dr. P.B. Murnal, initiated the meeting by welcoming honourable members of Senate & declared the meeting **open** and directed Prof. R.P.Chaudhari, Academic Registrar to conduct the proceeding as per agenda.

Item 1: Confirmation of Minutes and Action Taken Report of VIIth Senate.

Prof. R.P. Chaudhari read the minutes of VIIth Senate & Action Taken Report, which were noted and approved. The Academic Registrar also informed the Senate regarding item 8(2) wherein a complaint by Samajik Bhrashtachar Nirmulan Samittee against gross misuse of authorities in awarding Ph.D degree to one Mr. Yogesh Sathe was discussed & the Senate had resolved that the Principal should go through the complaint & inform the facts to Govt. of Maharashtra. However presently there is no communication to be placed before the Senate in regard to action taken report in respect of item 8(2).

Item 2: Proposal from Dean (Academic)

2 (i) Proposed structure of First Year Engineering from academic year 2012-13

The proposal was discussed at length and many members actively participated in discussion. It is suggested that Engineering Mechanics & Engineering Graphics should not be taught simultaneously in one Semester. The Examination pattern should be retained as 60+20+20. (60-Theory, 20-Class Test, 20-TA(which may include evaluation based on Surprise Test + Attendance + Assignment, etc.). Dr. Suhas Joshi insisted for Tutorials in two batches for selected subject which is accepted. It is resolved that proposal shall be referred back to the committee headed by Dean (Academic) for incorporating all suggestions & also for issue of guidelines for TA & shall implement it from academic year 2012-13.

Item 3: Proposal from Dean (R & D)

3(i) Proposal for approval of Ph. D. rules. It is resolved that the minimum age limit of 30 years as mentioned in rule (7.3) is unnecessary hence the words "less than 30 years and, not" shall be deleted Subject to above correction the Ph.D. rules are approved by Senate. Prof.R. P. Chaudhari insisted that the authorities should strictly follow these rules & should not use discretion .The chairman assured the house that he will go by these rules and nothing beyond this will happen.

3(ii) Proposal for amendment in Ph. D. Rules were noted and approved.

3(iii) Proposal for approval of Recognition of Research Guides were noted & approved.

3(iv) Proposal for approval of Provisional Registration, Credit Courses & Scholar was noted & approved.

3(v) Proposal for approval of extension of Registration of one year for Research Scholars was noted and approved.

3(vi) Proposal for approval of change in the Research Title for research research scholars was noted & approved.

Item 4: Proposal from Controller of Examination

4(i) Proposal for amendments in the examination Rules was noted and approved.

4(ii) Proposed Grade Point System from the academic year 2012-13 was noted and approved.

Item 5: Any other item with the permission of chair

5(i) Proposal received from Maharashtra Engineering Teachers Association for rotation of the Head of the departments was discussed by the teachers. So following the model of IIT, NIT and some Govt. Institutes, the heads shall be rotated. The chairman also supported this proposal. The Senate unanimously accepted this proposal in principle and requested the Principal, being the administrative head to take suitable decision in this regard.

The meeting concluded with vote of thanks by the chairman.
