# Item 24.2.25: Approval for equivalence of NPTEL courses suggested by Information Technology Department.

- 1) Following NPTEL courses are identified as equivalent for the final year B. Tech IT theory course curriculum, the similarity between the courses is above 80%.
  - i) NPTEL course noc22-cs90 CRYPTOGRAPHY AND NETWORK SECURITY is equivalent to theory course IT4064 Cryptography and Network Security
    - ii) NPTEL course noc22- cs96 INTRODUCTION TO INTERNET OF THINGS is equivalent to theory course IT4065 Internet of Things.
- 2) If a student of CBCS scheme, has an opportunity to undergo one-semester-long Internship / Industrial Training in VIIIth semester, he/she may be permitted to take it, however it will be mandatory to complete the Theory and Practical Courses of VIIIth semester in the following modes:
  - i) The department shall recognize NPTEL/ Swayam/ Other MOOC courses equivalent to the theory courses, get approved through the Board of Studies, and permit the students to undergo the course through this mode. Credit transfer may be given based on successful completion of NPTEL final examination.
  - ii) Laboratory courses shall be conducted as per curriculum and separate Time Table shall be prepared for such students.
